Thus JAC after consulting the respective State units has decided to observe the Strike on 27thÅ emerge out of the discussions proposed to be held between 19thÅ and the Management.Å Comrades, struggle is far from over. We have reached a crucial stage. We shall spare no stone unturned in bringing out satisfactory conclusions on the issues concerning our ranks through discussions. But if the Management chooses to fail in HONOURING their commitment we shall be left with no option except to carry forward the movement. Hence, we call upon our ranks to continue to remain in the battle field with the same spirit, zeal, enthusiasm and determination. March ahead, keep up the fighting spirit, victory shall be ours.
